

The Coral Triangle

Global distribution of coral reefs and species richness

Why reefs matter in the Coral Triangle?

Food and livelihoods

- 120 million people living in coastal areas
- Export income \$4 billion in fisheries exports.
 50% global tuna catch
- Employment 5 million+ people employed in fisheries processing.

Tourism

- \$12 billion in annual revenue from coastal tourism
- Coastal protection
 - 45% of shorelines protected by coral reefs



Why reefs matter in the Coral Triangle (1)?

Coral Triangle Initiative for Coral Reefs, Fisheries and Food Security

- CTI Plan of Action (2009): Overarching Goals:
- Designate and effectively manage priority seascapes
- Apply ecosystem approach to fisheries management
- Establish networks of MPAs
- Strengthen resilience and adaptation to climate change
- Strengthen measures to protect threatened marine species



CTI Overview

Status of the CTI

- ➤ Developed National & Regional plans of action; ongoing activities to support implementation
- ➤ Established interim Regional Secretariat; ratification & establishment of a permanent Regional Secretariat underway
- Financial & technical support from the CT6 governments & development partners (e.g., Australian government, USAID, GEF & ADB) and NGOs (CI, TNC & WWF)
- Other technical outputs: policy advances, refinement of tools and approaches, pilots demonstration/proof of concept, validation of strategy & policy

Strategic Framework

- ADB has been fully involved since the launch of the CTI in 2007 to provide technical and financial support
- Strategic Framework to Support the CTI:
- Strategy 2020. Environmentally sustainable growth as one of 3 development agendas, and environment as a core area of operations
- Regional Cooperation Strategies. CTI a flagship program under the BIMPEAGA
- > Country Partnership Strategies and COBPs

Programmatic Approach

1. Sustainable Finance

- a. High Level Financial Roundtable (May 2012)
- Assisted in undertaking an initial scoping of the priorities and financial requirements through a costing study
- Some of the action plans/projects have already been initiated. Began the process of mobilizing resources to support CTI goals

Programmatic Approach

1. Sustainable Finance

- b. Financial Architecture, Resource Mobilization & Strategic Roadmap Study
- Situational analysis of CTI ecosystems to identify critical threats and vulnerabilities
- Recommend and prioritize remedial actions and assess region-wide medium and long term (to 2025) resource requirements;
- Design of fund generation and mobilization mechanisms;
- Develop an institutional framework and strategic plan for sustainable financing of CTI action plans.

Programmatic Approach

2. Interventions of TAs/Grant Projects

- Strengthened regional cooperation among the CT6 on information exchange & decision making on coastal & marine resources management (KM TA)
- Increased resilience of coastal & marine ecosystems (CTI Pacific TA)
- Improved management of coastal & marine resources in the SSME Priority Seascape within the Coral Triangle (CTI SEA TA)
- Alternative livelihoods in the coastal communities (CTI JFPR Grant)

Programmatic Approach to the CTI (cont.)

- 4. Scaling up to full-fledged investment projects: Loan projects that have assisted or will assist in public or private sector investments
- Coral Reef Rehabilitation & Management Project (COREMAP-CTI)(2014-2018) - \$66 million (including \$45.5 million ADB loan and \$8 million GEF grant)
- Integrated Natural Resources and Environment Management Project (2014-2019) - \$154 million (including \$100 million ADB loan and \$2.5 million GEF grant)

Programmatic Approach to the CTI (cont.)

Establishment of the Business Development Unit (BDU)

- To oversee the implementation of the Financial Architecture for the CTI.
- Develop innovative and practical approaches to financing CTI RPOA/NPOA implementation including interfacing with the CTI Business Forum
- Match funding sources with needs and provide support to the Regional Secretariat and the countries in preparing proposals

Programmatic Approach to the CTI (cont.)

6. Program Pipeline

- GEF upscaling opportunities—BDU
- Sustainable financing studies
- Pilot projects
- Vulnerability assessments and M&E
