The main task of the Group was to improve results obtained by the Bioresources Development and Conservation Programme and to standardize methodologies for valuation of goods and services of Large Marine Ecosystems in Sub-Saharan Africa.

First Meeting of the Technical Advisory Group on Development of sub-regional contingency plans and sub-regional agreements for co-operation in cases of major marine pollution incidents, 25-27 April 2007

The two UNIDO/IMO/IPIECA Meetings were officially opened by the Deputy Minister for Harbors and Railways, Hon. Sophia Horner Sam, on April 23 2007. Capt. Georgina Jopap-Tackie, Project Director, UNDP Accra, chaired the opening ceremony.

In attendance were Dr. Chika Ukwe, Project Manager, UNIDO and Mr. Malamine Thiam, Technical Officer, Marine Environment Division of IMO and Mr. Phillipe de Suzane, IPIECA.

The Hon. Deputy Minister decried the rate of marine environmental degradation caused by oil spills, indiscriminate dumping of waste oil and ballast water. She commended the joint efforts of the IMO, IPIECA and IGCC in training the government and Industry representatives in oil spills preparedness and response within the framework of the IMO/IPIECA Global Initiative, to catalyze and promote effective oil spill contingency planning in the West and Central Africa (WACAF) region.

The Meetings attracted about 60 participants from maritime organizations and related institutions in the 16 countries of the IGCC as well as representatives of Oil Companies and the Private Sector.

The objectives of the Meetings were for participants to: undertake gap analysis and formulation of Action Plan for the development of in-country sensitivity maps; develop a regional guideline on oil spill sensitivity mapping; develop draft sub-regional contingency plans; develop a draft agreement for co-operation in cases of major pollution incidents.
