

ACTION 1

Capacity building and training to assure full participation of public and private sectors, local governments, NGOs and scientific institutions in the planning process through:

- → Organizing a Project Inception Workshop to discuss the methodological approach and to define the work programme.
- → Organizing a Training and Consultation Workshop for national consultants to define the scope of work and to assure a coherent approach in all activities,
- → Conducting a Training Workshop for Facilitators in Target Oriented Planning Methodology



ACTION 2

Reinforcement of NGO Participation in pollution reduction activities:

- → Organizating of consultation meetings to facilitate NGO participation in the planning process at national and regional level,
- → Creating a central structure / umbrella organization of all national NGOs in the Danube River Basin: "Danube Environmental Forum"
- Implementing a Small Grants Programme to reinforce community based pollution reduction activities initiated by national NGOs



ACTION 3

Reinforcement of planning activities at the national level concerning:

- **→** The elaboration of National Reviews (sector studies):
 - · Water quality and analysis of nutrient loads,
 - Identification of "hot spots" and development of project files,
 - Socio-Economic Analysis,
 - Analysis of Financing Mechanisms.
- → The organization of National Planning Workshops with participation of government, local administration,
 - NGOs, and scientific institutions (integrated approach): • Situation analysis and problem identification,
 - Analysis of objectives and definition of actions

 - Analysis of objectives and accommoderate supplier and impact indicators repair wash

ACTION 4

Support activities and development of regional policies, strategies and actions:

- → Support Activities :
 - Elaboration of Wetland Study
 - Development of Danube Water Quality Model
 - Development of Financing Mechanisms
 - Development of Thematic Maps
 - Establishment of ICPDR Information System
- → Regional policies, strategies and actions:
 - Summary Reports based on National Reviews
 - Transboundary Analysis
 - Pollution Reduction Programme Report
 - Project Files



ACTION 5

Inter-regional cooperation to prevent further degradation of Black Sea ecosystems through:

- Creation of an Ad-Hoc Danube -Black Sea Joint **Technical Working Group**
- → Elaboration of five reports on ecological indicators and changes over time of the Black Sea ecosystems (Bulgaria, Romania, Russia, Ukraine, Turkey)
- → Development of the Memorandum of Understanding on common policies and joint actions between Danube and Black Sea Protection Commissions
