Objectives

- ▶ In 1995 the GEF adopted the use of LMEs and the associated 5-module approach as the marine component of the International Waters portfolio. One of those 5 modules, Governance, is arguably a fundamental underpinning of all LME initiatives. Without appropriate governance arrangements in place, all other project modules or components can be difficult to implement, particularly in transboundary situations. However, governance is also perhaps the most difficult component to define and realize.
- ▶ The LME Governance session seeks to provide
 - ▶ 1) perspectives on overarching governance structures as well as
 - ▶ 2) share some select examples of mechanisms and tools (i.e. MPA, ICM, MSP) being applied in LME regions to facilitate effective governance of shared marine and coastal resources.
- ▶ This session does not seek to arrive at prescriptive solutions or advocate a one-size fits all approach. Rather it seeks to inform and initiate an open and ongoing dialog on how to address the need for appropriate and relevant governance structures and mechanisms throughout LME (and related project) planning and implementation.

Expected Outcomes

The LME Governance session is expected to:

- ▶ Expose governance issues within LMEs and how LMEs fit into existing global/ regional/ national governance arrangements and approaches
- ▶ Provide several project examples of approaches and tools being applied to provide shared experiences within the LME community
- ▶ Promote open and active consideration and integration of governance approaches by LME projects within a broader global context
- ▶ Provide a basis for discussion in regional caucus sessions to advance this aspect of the LME approach, including for example discussion related to potential LME project outcomes, activities, and outputs; in particular developing, implementing and advancing region and project appropriate governance structures and mechanisms to ensure sustainability of LME goods and services.
