Tuesday 3 December SESSION 1. LME Data and Information Management

Sub-session: LMEs experiences, successes and challenges regarding data and information management

Participant contribution: PowerPoint presentation on experiences within your LME



This is for LME Projects only (not other partners and participants)

LME projects to prepare a 10-minute (**maximum 10 slides**) presentation on current experiences, successes and challenges regarding data and information management and reporting on indicators. The presentation can **focus on the issues that are most relevant for your LME** and could include 2 or more of the following (as appropriate):

- a. <u>Website management.</u> How you ensure all project deliverables are available online, through project web-site and coordination with other organizations. What is the long-term plan to ensure availability of information after project completion?
- b. <u>Experience in reporting to IW:LEARN.</u> Key relevant reports produced and made available on IW:LEARN such as GEF IW experience and results notes, assessments, training material;
- c. <u>How data has been used in the project</u>: data sources, recording of metadata, publications and databases. What are the challenges to ensure long-term availability of data and data-based reports? What coordination is in place with scientists and research organizations
- d. <u>Indicators incorporated and reporting mechanisms</u>: links to SAP targets, SDGs, coordination with other regional organization indicators and reporting etc. What are the challenges to the regular reporting of key indicators?
- e. <u>Data management guidelines, tools and training.</u> Any good experiences in the development of guidelines, tools or training developed for data management (and assessments)? Or experience in the adaptation of other global and/or regional tools, guidelines and training. To include socioeconomic valuations, climate change assessments etc.
- f. Any other issues or recommendations to improve project data and information management
